**Invitation to Bid for “Improvement of Old CHIM
Building-Maddela Campus”**

ITB No.: QSU-BAC-J-40-2019

1. The *Quirino State University*, through the *National Expenditure Program of 2020*² intends to apply the sum of P 3,900,000.00 being the Approved Budget for the Contract (ABC) to payments under the contract for *Improvement of Old CHIM Building-Maddela Campus*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Quirino State University* now invites bids for *Improvement of Old CHIM Building - Maddela Campus*.³ Completion of the Works is required 210 Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *Quirino State University* and inspect the Bidding Documents at the address given below from 8:00AM – 5:00PM.
5. A complete set of Bidding Documents may be acquired by interested bidders on **October 29, 2019 to November 18, 2019** from the address, **2nd Floor Procurement/PPSD Office, Julian A. Alvarez Hall** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (₱5,000.00) only**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Quirino State University* will hold a Pre-Bid Conference⁴ on **November 06, 2019, 2:00 PM** at the **BAC Office, 2nd Floor Julian A. Alvarez Hall, Quirino State University, Diffun, Quirino**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **November 18, 2019, 2:00 PM**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **November 18, 2019, 2:00 PM** at **BAC Office, 2nd Floor Julian**

A. Alvarez Hall, Quirino State University, Diffun, Quirino. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
